F-1 STUDENT SEVIS TRANSFER FORM

This form should only be completed by students currently in F-1 status and currently or recently enrolled in a U.S. college or university.

Before we can issue you a Certificate of Eligibility I-20 for F-1 status to transfer to North Carolina Central University (NCCU), you and your current International Student Advisor at the school you are currently attending (or most recently attended) must complete this form and we must have copies of your current immigration documents: 1) signed and dated copy(ies) of the Certificate of Eligibility (I-20) from your current and any previous schools, if applicable (all pages of form I-20 are required); 2) I-94 Arrival/Departure Record (card or printout); 3) a valid passport copy; 4) F-1 visa page including the most recent entry stamp in the passport booklet; 5) If on OPT, a front and back copy of the EAD card. Please email these documents to North Carolina Central University Office of International Affairs at oiaisss@nccu.edu. To be eligible to transfer to NCCU, your SEVIS record must be in ACTIVE status. If your SEVIS record is NOT active, you will need to request a NEW initial I-20. Do not transfer your SEVIS record if it is Inactive or in Terminated status.
