Established in 1949, the program provides a project-based, service-learning enriched curriculum designed for students who are passionate about working with people, promoting active lifestyles, and enhancing quality of life in communities.</p> <p>The program emphasizes professional preparation for careers in a wide range of recreational settings, including municipal parks and recreation departments, high school, college and professional athletic programs, campus and military recreation, nonprofit agencies, rehabilitation centers, hospitals, state and national parks, commercial fitness facilities, and clinical and non-clinical environments.</p> <p>Students in the program may pursue one of three concentrations:</p> <ul style="list-style-type: none"> *Parks and Recreation Management *Recreational Sport Management (with options to minor in Business or Sport Coaching) *Recreational Therapy <p>All concentrations share a professionally accredited core curriculum that meets the standards of the Council on Accreditation for Parks, Recreation, Tourism, and Related Professions (COAPRT).</p> <hr/> <p>Provide the program-specific learning outcome consistent with COAPRT Standard 7.01: Students graduating from the program shall demonstrate the following entry-level knowledge: a) the nature and scope of the relevant park, recreation, tourism or related professions and their associated industries; b) techniques and processes used by professionals and workers in these industries; and c) the foundation of the profession in history, science and philosophy.</p> <hr/>

Students in the Introduction to Practical Experience in Recreation course (RECR2300) completed a practicum at a recreation agency and completed an Agency Analysis Class Project/Presentation assignment.

70% of students will score 70% or higher on the Agency Analysis Class Project/Presentation assignment as assessed by a rubric.

For the 2025 calendar year (Spring, Summer, and Fall semesters of 2025), 81.8% of Recreation Administration Program students (N=44) achieved 70% or higher on the Agency Analysis Class Project/Presentation assignment as assessed by a rubric.

Site supervisors complete the internship evaluation after the student's internship experience. In addition to the site supervisor's observations and interactions with the internship student, students submit a comprehensive analysis of the agency's management and operations. Each agency supervisor evaluates the student intern's ability to demonstrate entry-level knowledge about the operations and strategic management or administration in parks, recreation, tourism or related professions. The intern's ability to describe basic concepts, principles, and procedures related to the management/administration of the recreational agency was analyzed.
